4. No claims for injury to any person or damage to or loss of property because of fire, theft, or any other cause, shall be made against OPSAIL CONNECTICUT, INC. or City of New London, its officers, or agents, by or for Lessee because of this agreement.
5. Lessee agrees to indemnify the OPSAIL CONNECTICUT, INC. and the City of New London and hold both harmless of and from all claims for personal injury, death or property damage and any other losses, damages, charges, or expenses, including attorneys' fees, which arise out of, in connection with, or by any reason of use of the space provided herein, by Lessee.
6. It is agreed that the OPSAIL CONNECTICUT, INC. will not be liable for conditions caused by war, acts of terrorism, insurrections, riots, acts of God, force majeure, medical emergencies, omissions, or delays in acting by any governmental authority or the other party. In such an event, the OPSAIL CONNECTICUT, INC. liability is limited only to the return of all rental monies previously paid by Lessee.
